## Receiving Your Certificate

Candidates will be mailed their certificates according to the schedule below. Only candidates who have passed the FRM Exam and provided GARP with proof of their 2 years of professional work experience will receive a certificate. Once you receive an email notification that you passed the FRM Exam, you will need to upload and/or complete your CV/Resume by **verifying your professional experience**. You may not use the FRM designation until GARP verifies that you have met the full-time professional work experience requirement.

**Important:** You have 5 years from the date you passed the FRM Exam to submit your CV/Resume to GARP by **verifying your professional experience**. If you fail to submit your CV/Resume within the 5 year timeframe then you will have to retake the FRM Exam to become a Certified FRM.

If your certificate does not arrive due to an incorrect or insufficient address, you will be assessed a \$100.00 fee to re-issue the certificate. For GARP members that have lost their certificates; or wish to receive a duplicate certificate, there is a \$100 replacement fee. Your credit card information and expiration date are required in order to have your certificate re-issued.

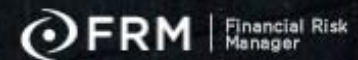

GARP's certification requirements require candidates to meet two criteria.

- A passing score on the FRM/ERP exam
- At least two (2) years of work experience in the area of financial risk management or another related field including, but not limited to trading, portfolio and/or risk technology. This real-world practice orientation underlies GARP's FRM/ERP philosophy.

#### Proof of Two Year Professional Work Experience:

To receive the actual FRM/ERP Certificate, a candidate must possess relevant professional work experience prior to being formally certified as a financial risk management expert by the FRM/ERP Committee and GARP's Board of Trustees. This real-world practice orientation underlies GARP's FRM/ERP philosophy.

We require each candidate to provide at least 4 to 5 sentences on how YOU use financial risk on a daily basis in your job(s) that cover a two year period. Please do not explain what your company is currently involved in. Listing your job title alone is insufficient information. When you provide this background information, we will be in a better position to determine if your experience meets our requirements for certification. You have five (5) years from the date you took and passed the exam to submit this information.
