- Is issued by a national government which certifies, for the purpose of international travel, the identity and nationality of its holder;
  - Passport cards, national identification cards, limited travel documents, internal passports, and passports that are clipped, hole-punched, or marked cancelled **are not valid forms of identification** for the CFA Program. [Learn more](#)
- Is an original document (photocopies are not allowed) and is current (not expired);
- Contains your name, date of birth, passport number, expiration date, and the name of the country that issued the passport;
- Is [machine readable](#) (handwritten passports will not be accepted); and
- Includes a recognizable photograph on the passport data page.
