



- note:
 - A deferral to the next examination period must be submitted by the last day of Registration. For example, the last day of registration for May is April 15th; and for November's Exam the last day of registration is October 15th.
 - There is an administrative processing fee of USD 100 and this fee must be payable via credit card at the time of your request.
 - If you change your mind after submitting the Deferral Form and want to sit for the FRM exam during the current exam period, you need to contact GARP by the last day of the current Registration period, there is an administrative processing fee of USD 100.
 - As a deferred FRM Candidate, you will automatically be re-enrolled in the next cycle. If you
 decide not to attend the next exam, you will forfeit all exam fees and have to re-register as a new
 candidate.

Note: Any study materials you purchased for this year's exam may not all be applicable for next year's exam since the Study Guide and suggested readings will change from year to year.
